**Note 4:** Cash Balance in the checking account includes a pending transfer of \$2,450 to the USOF Endowment Fund, Inc. and 2016 additional Insurance premiums of \$15,300.

**Note 5:** The Endowment Fund equity balance reflects the Fair Market Value of the endowment assets held and invested by USOF Endowment Fund, Inc. as of 12/31/2015 plus accrued late December Endowment contributions.
